We celebrate diversity of thought and embrace innovation and creativity. We do not apply a one-size-fits-all all to the work we do.

## **Community:**

We foster a sense of belonging and camaraderie within the SSH advocate community.

We actively contribute to the collective knowledge and success of the community, sharing insights, experiences, and resources to support each other's growth.

# Code of Conduct

## Respect:

- We treat all individuals with respect, regardless of differences in opinion, background, or affiliation.
- We listen attentively, value diverse perspectives, and refrain from engaging in disrespectful or derogatory behaviour.
- We seek to respond positively, taking a helpful and constructive communication approach, especially on divisive and challenging issues.

## Professionalism:

- We conduct ourselves with professionalism and integrity at all times.
- We adhere to ethical standards and honour commitments, maintaining transparency and accountability in our actions.
- We seek and openly accept feedback
- We actively contribute to the advocate community through the behaviours and expectations outlined.
- We support the running of the advocates' community by evidencing participation and responding to queries from advocate community leads in a timely manner.

## Collaboration:

- We promote collaboration and teamwork, recognizing that collective efforts yield greater impact.
- We seek opportunities to collaborate with fellow advocates, organisations, and stakeholders to enable organisations to achieve better outcomes and a more humane world of work

## Inclusivity:

- We strive to create an inclusive and welcoming environment for all advocates, ensuring everyone feels valued and heard.
- We actively work to address biases, barriers, and inequalities within the advocate community, promoting diversity and equity.

## Confidentiality:

- We respect the confidentiality of sensitive information shared within the advocate community.

- We uphold the trust and privacy of fellow advocates, refraining from sharing confidential information without explicit consent.

Compliance:

- We comply with all applicable laws, regulations, and policies governing our advocacy activities.
- We refrain from engaging in any activities that may bring disrepute to the SSH movement or compromise its values and principles.

Violation of the Values & Code of Conduct may result in consequences, including but not limited to:

- Temporary suspension or permanent expulsion from the Sooner Safer Happier Advocate community.

- Reputational damage to individual advocates and potential impact on professional relationships.
- Legal action in cases of serious misconduct or violation of laws and regulations.
